(RESIGNATIONS ARE EFFECTIVE THE END OF A MONTH ONLY.) ARTICLE IV, SECTION 3 OF THE BY-LAWS STATES: **A SHARE OF STOCK IN THE GEORGETOWN COUNTRY CLUB SHALL BE VALUED AT \$150.00; A REFUND OF \$100.00 TO BE MADE ON A SURRENDERED SHARE WHEN IT IS RESOLD BY THE CLUB.** MEMBERSHIP IN THE GEORGETOWN COUNTRY CLUB SHALL BE CONTINGENT UPON THE APPROVAL BY THE BOARD OF DIRECTORS, PLUS THE PURCHASE OF A SHARE OF STOCK PLUS A NONREFUNDABLE INITIATION FEE, PLUS ONE MONTH'S DUES SHALL BE REQUIRED TO BE PAID IN ADVANCE. THE BOARD OF DIRECTORS SHALL ESTABLISH THE INITIATION FEE.
